Joe has had direct executive responsibility for a large number of the DOR programs which have included Blind Field Services, the Orientation Center for the Blind, the Older Individuals who are Blind Program, the Deaf and Hard of Hearing Section, the Business Enterprises Program, the Independent Living Unit, the Assistive Technology Unit, the Disability Access Section, the Client Assistance Program, the Public Affairs Office, and the Traumatic Brain Injury Program. Understanding the hiring process for a person with blindness or visual impairment, and each person's role in the process.

Philip Kum, Management Analyst, EPA

Philip Kum is a management analyst in the US Environmental Protection Agency's San Francisco office. He manages personnel programs including the Reasonable Accommodations Program, the Student Volunteer Program, the Disability Employment Program, and the Region's Telework Program.

Philip has previous experience as a program coordinator at the LightHouse for the Blind. He is also highly involved in the growing sport of Blind Sailing.

Candace Hudson, Reasonable Accommodations Coordinator, DMV

Candace L. Hudson is the Reasonable Accommodation Coordinator at the Department of Motor Vehicles. Candace administers the Reasonable Accommodation Program to approximately 9,000 DMV employees, she acts as an advisor on DMV's Disability Advisory Committee, and is also the Ergonomics Contracts Co-Administrator. Candace has over 30 years of state service, 20 years with DMV, and six years as the RAC.

Jeff Thom, Attorney, immediate past president of the California Council of the Blind

Born in 1953, Jeff Thom grew up in the San Francisco Bay Area. In 1975, Jeff Thom graduated from Willamette University with his Bachelor of Arts degree in political science, after which he received a J.D. degree from

Stanford Law School in 1978. After working for a year as a disabilities rights attorney, Jeff began his employment with the California Office of Legislative Counsel where he worked until his retirement in 2010. In that nonpartisan capacity, he supervised the drafting of bills and the legal opinions relating to health and human services and workers' compensation. Jeff is married, has three children, and is involved in various community activities. He is immediate past president of the California Council of the Blind, an organization of which he has been a member for almost 35 years, and currently serves as that organization's legislative advocate. He serves on the board of directors of the American Council of the Blind and the board of trustees of the American Foundation for the Blind. Jeff served as chair of the City of Sacramento Disability Advisory Commission and currently serves as a member of the Sacramento Regional Transit District Mobility Advisory Council and also as a member of the Blind Advisory Committee of the California Department of Rehabilitation. In 2008, Jeff Thom was named California Public Lawyer of the Year. He has also received awards for his service in the field of blindness.

Kate's passion is supporting blind and visually impaired job seekers to secure employment in the competitive job market. Kate experienced vision loss late in her career and has drawn on her twenty plus years of experience as an HR professional to serve as the basis for developing employment workshops and job coaching activities.

She served in an HR generalist capacity for ten years with a leading international pharmaceutical company, recruiting national field sales forces and executive management. Kate received special commendation for the recruitment and retention of minority employees. When relocating to San Francisco fifteen years ago. Kate begin a successful career in Executive Recruitment. She is recognized as a leading employment coach and motivator. Kate serves on the San Francisco Chapter Board of NCHRA (Northern California Human Resources Association). Prior to joining the Lighthouse, Kate worked in collaboration with Adaptive Technology to develop Employment Workshops for DOR consumers.

Ms. Harper is currently a member of the Board of the Lighthouse for the Blind, has served on the Governor's Committee for the Employment of Disabled Persons and in 1995 became the first recipient of The Glaucoma Foundation Award of Merit, which recognizes an individual whose life has been profoundly affected by glaucoma and who has responded to the challenge with courage and distinction. Ms. Harper obtained her Certified Investment Management Analyst designation through the Wharton School of Business and is an active member of the Association of Professional Investment Consultants (APIC) and the Investment Management Consultants Association (IMCA).

Douglas Gerry, General Manager, A.T. Kratter & Co.

Douglas is currently the general manager of A.T. Kratter & Co. Inc., an adaptive technology product and service company based in Southern California. Douglas has been in the adaptive technology industry since losing his eve sight due to Retinitis Pigmentosa in the late nineties. After losing his sight he no longer felt the same satisfaction in this industry and knew it was time for a change in career. Douglas set out to learn the skills that are important to being a fully independent blind individual and quickly learned that technology was a main ingredient to success in his chosen career. Douglas is the beneficiary of support from the Department of Rehab who assisted him to obtain both the blindness skills training and the technology training he received right here in the Bay Area. Although Douglas currently lives in Orange County with his Guide Dog Jude, his heart is still in the Bay, and hopes to return one day.

Rick Watson, Lead Steam Fitter, HVAC Mechanic U.C. Berkeley

Rick has worked in the HVAC industry for over 30 years. The slow loss of vision from Retinitis Pigmentosa has forced a new outlook on life and career. With the generous assistance and support from his family, friends, the Department of Rehabilitation, and The National Federation of the Blind, Rick has been able to accept his impending vision loss through Assistive Technology, and training. Rick uses AT in his every day work life and is not shy about talking (bragging) about it.

David Hoffman, Material Components Analyst, Electronic Components Distribution

David is a 47 year old low vision employee of an international Electronics Components Distributor. He has been working for the same company in both Canada, where he was born, and in the USA, in the South Bay area for the last 19 years. David lost vision in one eye at a very young age to retinoblastoma, an eye cancer, and lost most of his vision in his other eye in February of 2009. David was able to maintain his position after his vision loss.
